FRONT DOOR PERMANENT SUPPORTIVE HOUSING WORKS WITH HOMELESS FAMILIES REFERRED BY DAFFODIL ELEMENTARY IN SUMNER AND JENNY REED ELEMENTARY IN TACOMA. IN THIS PROGRAM, THE FAMILY IS ASSISTED IN LOCATING HOUSING, AND THE LEASE IS IN THE FAMILY'S NAME. THE FAMILY PAYS 30% OF THEIR ADJUSTED GROSS INCOME. EDUCATION IS A MAIN FOCUS FOR BOTH CHILDREN AND ADULTS. FINANCIAL LITERACY, PARENTING, AND EVENTUAL EMPLOYMENT IN A CAREER WITH UPWARD MOBILITY ARE PRIORITIES. THE SCHOOLS PROVIDE DATA REGARDING GRADES, ATTENDANCE, AND BEHAVIOR FOR THE CHILDREN. OUR SPECIALIST WORKS WITH CHILDREN WHO ARE HAVING DIFFICULTY IN ANY OF THESE AREAS; DEVELOPING A PLAN TO RECTIFY THE SITUATION AND PROVIDING GUIDANCE TO PARENTS. DURING 2012 15 FAMILIES WERE SERVED INCLUDING 22 ADULTS AND 34 CHILDREN. ADULT HOUSEHOLD MEMBERS ARE ENGAGED IN AN

FAMILIES ARE PLACED IN SCATTERED SITE HOUSING IN PUYALLUP AND SUMNER. THE FAMILIES PAY 30% OF THEIR ADJUSTED GROSS MONTHLY INCOME IN RENT. THEIR UTILITIES AND THE BALANCE OF THEIR RENT IS PAID BY HELPING HAND HOUSE. CASE MANAGEMENT IS PROVIDED WEEKLY OR MORE OFTEN AS NEEDED. FAMILIES ARE REQUIRED TO ATTEND LIFE SKILLS CLASSES AND PARTICIPATE IN FINANCIAL LITERACY CLASSES. EMPLOYMENT AND EDUCATION ARE FOCUSED ON FOR ADULT HOUSEHOLD MEMBERS. THE CHILDREN ARE PROVIDED WITH A WIDE VARIETY OF LOCAL RESOURCES TO HELP THEM IMPROVE THEIR LEARNING ABILITY AND WORK AT GRADE LEVEL. AT THE END OF THIS 24 MONTH PROGRAM, THE FOCUS AND GOAL IS TO HAVE THESE FAMILIES BE SELF-SUFFICIENT AND NO LONGER NEEDING OUTSIDE

FAMILIES ENTER THIS PROGRAM AND ARE PLACED IN 1 OF 9 SCATTERED SITE HOMES FOR A PERIOD UP TO 90 DAYS. DURING THIS TIME THEY PAY NO RENT, UTILITIES, OR TELEPHONE BILLS. THEY DON'T PAY FOR PERSONAL HYGIENE, LAUNDRY, OR CLEANING SUPPLIES. THEY PARTICIPATE IN AN ASSESSMENT TO IDENTIFY THEIR BARRIERS, AND A PLAN IS DESIGNED TO HELP THEM OVERCOME AS MANY OF THOSE BARRIERS AS POSSIBLE. DURING THEIR ASSESSMENT, CONSIDERATION IS MADE FOR ANY OPENINGS IN OUR OTHER PROGRAMS. EMPLOYMENT IS SOUGHT, AND CONNECTIONS TO RESOURCES FOR THEM AT THE END OF THE 90 DAYS ARE IDENTIFIED. IN 2012, 28 FAMILIES WERE SERVED INCLUDING 42 ADULTS AND 70 CHILDREN.
